Outside cakes or dessert items will be allowed into the Kemmerling Pool facility. If you have special food items that you would like guests to have, outside of these stipulations, these items may be consumed outside of the pool facility in Kemmerling Park.

A full refund, less a \$5 service charge, will be issued if cancellations are made a minimum of two weeks in advance. Cancellations made less than 2 weeks in advance will only be refunded if another party can be booked on the same date.

In the event of inclement weather and pool closure, you will be allowed to reschedule your party for no additional cost.

## Kemmerling Pool Rules & Regulations

1. Parents or guardians are responsible for supervising their children. Lifeguards are responsible for enforcing safety rules and responding to emergencies.
2. Parents or guardians must remain within an arms length of small children at all times.
3. Children under 9 years old must be accompanied and actively supervised by a guest 16 years and older to enter the facility. Unaccompanied children will be asked to exit the water until their guardian is located.
4. Per State mandated health regulations, admissions to the pool shall be refused to all persons having any contagious disease, infectious conditions such as colds, fever, ringworm, foot infections, skin lesions, diarrhea, vomiting, inflamed eyes, ear discharges, or any other condition which has the appearance of being infectious. Persons with excessive sun-burn, abrasions which have not healed, corn pasters, bunion pads, adhesive tape, rubber bandages, or other bandages of any kind shall also be refused admittance. A person under the influence of alcohol or exhibiting erratic behavior shall not be permitted in the pool area.
5. Spitting, spouting of water, blowing the nose or otherwise introducing contaminants or bodily fluids into the pool is not permitted.
6. All persons are encouraged to take a shower before entering the pool area.
7. Guests must wear commercially sold swimsuits to participate in recreational aquatic activities. No street clothes, cut-offs, underwear, inappropriate swim suits or street shoes may not be worn in the pool.
8. All apparel and footwear brought into the facility and worn on the deck must be clean.
9. People in street shoes are not allowed on the pool deck or in the wet areas of the bathhouse.
10. Illinois state pool code requires that, all children who are not toilet trained are required to wear tightly fitted rubber or plastic pants over diapers, or approved disposable swim diapers. \*Swim diapers are for sale at the admissions desk of the pool
11. Flotation devices including but not limited to: inner tubes, float belts, blow up devices, water wings, swim suits that incorporate flotation devices whether sewn in or not are not allowed in the pool during open swim/public hours.
12. Swimming accessories such as beach balls, kickboards, squirt guns, diving rings, rafts, and other such items are not allowed in the pool during open swim/public hours. Face masks and goggles containing glass lenses are not allowed and must not have nose coverings.
13. Strollers are permitted on deck, but the wheels must be clean and they must remain 4 feet from the perimeter of the pool at all times.
14. Guests are encouraged to make any special needs known to the management, and we will be happy to assist you.
15. All patrons must obey lifeguards, management and other pool staff. Conduct inside the facility must be safe and courteous. Running, boisterous or rough play, use of foul or inappropriate language, or other acts of belligerence towards staff or other guests will not be tolerated.
16. No running on deck at any time.
17. A safety break will be taken each hour- in which everyone in the pool must exit the water. A 15 minute adult swim will be provided for guests 18 & over at this time.
18. Portions of Kemmerling Pool may be closed at the discretion of management at any time due to unsafe conditions. No refunds will be issued.
19. Guests must able to swim the length of the dive well in order to use the drop slide or dive platforms.
20. For your safety, back dives and back flips are not allowed.
21. Diving in water less than five feet deep is not permitted expect when allowed for competitive swimming and training.
22. Please lock your belongings. The Roselle Park District is not responsible for loss or theft of any personal items. Lockers are available for daily use only. No items may be left overnight. Guests must provide their own lock.
23. Outside food and beverage, including coolers, are not allowed inside the facility. Glass containers of any kind are not allowed in the facility.
24. Personal lawn furniture is allowed on the grass turf area only.
25. Personal radio devices must be used with headphones. Any other electronic devices such as cell phone must be restricted to low volume for personal use to avoid disturbing other pool patrons.

26. Cell phone usage is prohibited in the locker rooms.
27. Smoking and alcohol are strictly prohibited on park district grounds.
28. Pets are not allowed in Kemmerling Pool.
29. Use of outdoor swimming pools is prohibited when thunder is heard or lightning is seen, including a 30- minute period after the last lightning or thunder is detected.
30. Guests may re-enter the facility by obtaining a hand stamp prior to leaving the front admissions desk. Re-entry may be delayed when the facility is at maximum capacity. Do not leave children unattended inside the facility.
31. Refunds will not be given for any early closings, including those due to weather.
32. During open swim hours, staff trainings may occur on deck. This includes management placing a safety mannequin into the pool for a practice rescue.
33. There is a \$10 replacement fee for lost or stolen photo ID pool passes and are available at the CRC.
34. Management may modify these regulations at any time to ensure the safety of our guests.
35. Failure to abide by these regulations may result in disciplinary action and the possibility of ejection from the facility.
